# Murray Grey Northern Bull SALE 2014

### **CONDITIONS OF ENTRY**

The Murray Grey Northern Bull Sale is Society sponsored. It is the responsibility of members entering cattle to understand the Conditions and be aware of implications arising from them.

In addition to the Northern Bull Sale Conditions of Entry, the following extra conditions also apply: (Special attention should be given to them)

- The lodging of an entry shall denote that the Vendor (Nominator) accepts the Conditions and undertakes to comply with them.
- All animals must be recorded with the Murray Grey Beef Cattle Society Limited in either the Purebred, Grading, Black Factor or Greyman registers and all Vendors must be full financial, junior, educational or life members at the close of entries.
- All animals must be active at the time of entry.
- > There will be a limit on the number of lots to be offered for sale at the Murray Grey Northern Bull Sale, this number will be determined by the committee and the agent. This will therefore mean that vendors offering more than one animal for sale may be asked to withdraw one or more lots.

All animals will be sold with physical possession being given to the purchaser, together with a minimum of three-quarter share ownership including semen rights.

1. ANIMAL ELIGIBILITY (Please note that ages are as at sale day)

Minimum age 18 months & 0 days, maximum 30 months & 0 days as at 15th September 2014.

#### All animals are subject to the following criteria:

All stock MUST be in the charge of the exhibitor or his/her representative at all times.

Scrotal circumference: Bulls shall have a scrotal circumference measurement of not less than 34cms.

**Teeth/Age:** Teeth will be checked.

18 to 24 months - no more than two teeth. 24 to 30 months - no more than four teeth.

#### Sale of Share Ownership in Animals:

All animals will be sold with full physical possession.

A maximum of a one-quarter share can be retained in any animal but with no further call on that animal.

Also, the Vendor is to declare if semen has been collected and his/her intention regarding the retained share, i.e. use in own herd, or market licensed semen, etc.

Details of conditions being applied by a Vendor to a Lot must be specified on the Entry Form so that the information is published in the sale catalogue.

#### **DNA Profile**

All bulls will be required to have DNA results on file with the Society before Friday 4th July 2014.

#### Pestivirus Requirements

A Pestivirus test must be carried out on all lots with the results to the society prior to the 4<sup>th</sup> July. This is a low cost hair sample test that is conducted by Elizabeth Macarthur Agricultural Institute. For Hair Sample Kits contact (02) 46406327.

#### Recessive Genetic Factors (RGF)

While it is not compulsory to test for the RGF's AM, NH & CA, it is highly recommended. The genetic status of all animals offered for sale will be listed in the sale catalogue.

#### **Vet Inspection**

All animals will be required to pass a vet inspection on Sunday 14th September 2014.

- Inspections will be for breed standard of excellence and measurements. The scrotal circumference and soundness inspection will be conducted at the sale inspection.
- Animals that fail inspection criteria may be re-inspected at the discretion of the inspector.
- ➤ The Murray Grey Beef Cattle Society reserves the right to reject any entries at its absolute discretion.
- ➤ On-farm inspections by an AACV veterinarian are recommended.
- The decision of the sale committee will be final and no discussion will be entered into.

#### **Black Factor Animals**

All Black Factor bulls must be freeze branded with official MGBCS brand. Contact the MGBCS to get access to a brand.

#### 2. SUBSTITUTIONS:

In the event of a nominated entry being unable to be offered at the Northern Bull Sale, a substitution will be permitted, provided the information on the substitution is provided by Monday 8th September 2014. All substitution entries must meet all eligibility requirements.

#### 3. RESERVE & FLOOR PRICE

The MGBCS reserves the right to set floor prices for each class of animal included in the sale. Vendors have the right to set a reserve price on each and every animal in the sale.

#### 4. BJD Requirements:

Certain BJD requirements will be required to be met for animals entering into QLD depending on the status of their point of origin. #### 5. TATTOOS

All entries shall be inspected for tattoos. Entries with missing or illegible tattoos will be ineligible for sale. **NO EXCEPTIONS WILL BE MADE**.

#### 6. INSPECTION, WEIGHING, MEASURING AND SCANNING OF BULLS

All bulls shall be inspected for breed standard of excellence and structure, weighed, measured for hip height & scrotal size, scanned for fat depth and eye muscle area on Sunday 14<sup>th</sup> September 2014 at the Roma Saleyards. Recommended but optional that bulls are minimum 5 frame score. This data plus their age shall be displayed in the supplementary sheet. A vet will also be inspecting each animal at the sale.

#### 7. MURRAY GREY GROUP BREEDPLAN EBVS

Entries must have a minimum of growth EBV's (birth weight, 200, 400 & 600 day weight) available at the time of entry. Group BREEPLAN EBVs are inserted automatically in the sale catalogue.

#### 8. TRANSFER OF OWNERSHIP

By agreeing and signing the Sale Conditions of Entry, all animals will be transferred by the MGBCS after the Sale. If there are any associated fees, vendors will be responsible for payment of these.

#### 9. ENTRY FORM

The accompanying Entry Form must be completed, signed by the vendors and returned to the MGBCS Office by Friday 27th June 2013.

#### 10. ORDER OF SALE

Exact order to be determined after entries close. Murray Greys will sell first followed by Greyman entries.

#### 11. COMMISSION

The total commission charged by the Selling Agents on Lots sold is 6%, comprising 5% Agent's Commission, and 1% Society Sponsorship Levy.

#### 12. AGENTS

Selling Agent in association is Grant, Daniel & Long (GDL).

Contact your Selling Agent if you require marketing advice. It is suggested that nominators liaise closely with the agent and seek inspection of their entry or entries on property prior to the closing date for entries.

#### 13. OUTSIDE AGENTS

There will be a 3% rebate for outside agents.

#### 14. OPTIONAL VACCINATION HISTORY

Please indicate if your animals have been vaccinated for any of the following: leptospirosis, 5 in 1, 7 in 1, vibriosis, 3-day sickness, pesti virus or 3 germ.

# 15. IT IS HIGHLY RECOMMENDED THAT VENDORS HAVE BULLS EXAMINED BY A VET ON FARM BEFORE THE SALE.

It is an option for Vendors, on their own initiative, to supply a Bull Examination Certificate as approved by the Australian Association of Cattle Veterinarians, covering:

- Physical examination
- Serving ability
- Serving capacity
- Special diagnostic

#### **SCHEDULE OF FEES:**

ENTRIES WILL NOT BE ACCEPTED UNLESS ACCOMPANIED BY THE APPROPRIATE FEES. Fees quoted include GST. Tax invoices will be issued on receipt of fees.

Withdrawal of entries: - If an entry is withdrawn prior to closing date, fees will be refunded after deduction of \$55 (GST inc) handling fee. ALL ENTRY FEES ARE NON-REFUNDABLE ONCE ENTRIES HAVE CLOSED.
